FIRST PRESBYTERIAN CHURCH OF GREENVILLE, SOUTH CAROLINA BYLAWS OF CORPORATION AMENDED AND RESTATED AS OF NOVEMBER 15, 2020

ARTICLE I

Preamble

First Presbyterian Church of Greenville, South Carolina, a South Carolina corporation (hereinafter referred to as the "Church" or the "Corporation") is a member congregation of ECO: A Covenant Order of Evangelical Presbyterians, a reformed body of churches (hereinafter referred to as "ECO") and of an ECO Presbytery. As such, the Church subscribes to the ECO Essential Tenets and is governed by the ECO Polity and Discipline ("ECO Constitution").

This Corporation shall constitute the legal entity through which the Church shall act as described in the ECO Constitution. These Bylaws set forth provisions for the operation of the Board of Directors of the Corporation. It is the intent that the Bylaws of the Corporation shall conform to the requirements of the laws of the State of South Carolina and the United States, and conform to the ECO Constitution. These Bylaws replace and supersede all preexisting Bylaws of the Church (the most recent being November 10, 2013).

ARTICLE II

Corporate Status

By Act of the General Assembly of the South Carolina Legislature, dated December 20, 1853, 12 Statute 235, the Corporation was incorporated as the Washington Street Presbyterian Church in Greenville, S.C. By Act of the General Assembly, dated February 10, 1912, the charter of the Corporation was amended to reflect that the Washington Street Presbyterian Church had changed its name to the First Presbyterian Church of Greenville, S.C. The Act further provided that the title to all property vested in Washington Street Presbyterian Church was thereby vested in the First Presbyterian Church of Greenville and declared that the Board of Trustees of the Corporation was "charged with such duties in connection with the care, custody, control and management of the real and personal property of the Corporation as may be assigned to them by the Session of the Church". In Bylaws adopted by the Corporation on April 3, 2011, in order to conform with modern standards of corporate law, the term "Board of Directors" replaced the term "Board of Trustees".

ARTICLE III Directors and Directors Meetings

<u>Section 1</u>. <u>Members of the Board of Directors</u>: Consistent with ECO Polity, the Session shall constitute the Board of Directors ("Directors").

<u>Section 2.</u> <u>Number of Directors; Term</u>. Elders elected to the Session by the members of the congregation of the Church ("Covenant Partners" under ECO Polity) are automatically to serve as the Directors of the Corporation. The election shall occur at the annual meeting of the Corporation or at a special meeting of the Corporation called for that purpose. The Board of Directors shall be divided into three (3) classes the same as their classes for serving as Elders on the Session. Each class shall be elected for a term of three (3) years which begins on the day which coincides with the beginning of the term for the members of Session.

<u>Section 3</u>. <u>Nomination to the Board</u>. Nominations for Board of Directors shall be made by the same procedure and same Nominating and Discernment Committee that nominates officers of the Church.

<u>Section 4</u>. <u>Meetings and Quorum</u>. The Board of Directors shall meet at least annually. Special meetings of the Board of Directors may be called by the Chair and may also be called by a majority of the active Directors serving on the Board. Notice of all meetings of the Board shall be given to all Directors, in writing, using the same notice requirements for a Session meeting. The requirement for a quorum shall be the same as that required for a Session meeting. Provided a quorum is present, action or resolution on any matter or question shall be decided by a simple majority of the Board members present.

<u>Section 5</u>. <u>Vacancies</u>. Vacancies and newly created positions resulting from any increase or decrease in the authorized number of Directors shall be filled by election at the next annual meeting of the Corporation or at any special meeting of the Corporation called by the remaining Directors for that purpose. Should the number of Director vacancies cause the then remaining number of Directors to fall below three (3) members (the minimum number of Elders under ECO Polity), a special meeting of the Corporation will be held to fill such vacancies for the unexpired terms of such Directors.

<u>Section 6</u>. <u>Responsibilities of Board</u>. The responsibilities of the Board of Directors shall include the functions required by the following:

- 1. ECO Polity, including the power to:
 - a. Receive, hold, encumber, manage, and transfer property, real or personal, provided that in buying, selling, and mortgaging real property, the trustees shall act only after the approval of the congregation, granted at a duly constituted meeting.
 - b. Accept and execute deeds of title to such property, and hold and defend title to such property.
 - c. Manage any permanent special funds for the mission of the congregation
- 2. To comply with relevant laws of the State of South Carolina and the United States.
- 3. To comply with Internal Revenue Service requirements to maintain the Corporation's status as a non-profit entity.

<u>Section 7.</u> <u>Committees</u>. The Board may establish committees and appoint members of the Board of Directors to serve on such committees. Each committee may exercise such powers that the Board of Directors confers upon such committee by resolution. The Board may also select individuals not serving on the Board to committees as it deems appropriate. Absent a unique task to be performed, it is expected that the Committees of the Session will perform the tasks necessary for the Board to fulfill its responsibilities.

Section 8. Officers. The officers of the Board of Directors shall be:

- 1. Chief Executive Officer and Chair of the Board: the Pastor
- 2. Secretary: the Clerk of Session
- 3. Treasurer: the Chair of the Finance and Stewardship Committee

ARTICLE IV

Meetings of the Corporation

<u>Section 1</u>. <u>Annual Meeting of the Corporation</u>. There shall be an annual meeting of the Corporation. The annual meeting shall be attended by the Covenant Partners of the Church at the time of the meeting. The Chair of the Board, or the Chair's designee, will preside. The business at such annual meeting shall be stated in the notice and shall be limited to the matters delineated in ECO Polity as follows, or any other matters required or allowed under applicable law:

- 1. Electing elders/directors and deacons.
- 2. Calling a pastor/head of staff, associate pastor, or to request the dissolution of such calls.
- 3. Buying, mortgaging, transferring, or selling real property.
- 4. Requesting that presbytery dismiss the congregation to another presbytery of ECO, or requesting that the presbytery dismiss the congregation to another Reformed body.
- 5. Approving any amendments to the Corporation's Articles of Incorporation, Bylaws or other corporate governing documents and dissolution, merger and any other corporate action requiring voting member approval.
- 6. Authorizing assistant pastors to serve on session with voice and vote by the congregation's own rule.
- 7. Whenever permitted by law, both ecclesiastical and corporate business may be conducted at the same Corporation and congregational meeting.

<u>Section 2</u>. <u>Special Meetings</u>. The Board of Directors may call a special meeting of the Corporation for matters appropriate to the Corporation. A special meeting shall be called on written request of a majority serving on the Board of Directors. Such written request shall state clearly the purpose of such meeting, and the business to be transacted at such special meetings shall be limited to the purpose stated in the written request. A meeting of the Corporation may also be called by a petition signed by at least twenty-five (25%) percent of the Covenant Partners of the Church. The purpose of such meeting shall be stated in the petition and shall be limited to the matters delineated in Section 1 above.

<u>Section 3</u>. <u>Notice of the Meetings</u>. Notice to the Covenant Partners of the Church of the time, place and purpose of all meetings (annual or special) of the Corporation shall be given at least fourteen (14) days prior to the meeting (which must span two (2) Sundays).

<u>Section 4</u>. <u>Quorum</u>. A quorum of a meeting of the Corporation shall be at least ten (10%) percent of the Covenant Partners of the Church. Provided a quorum is present, action or resolution on any matter or question shall be decided by a simple majority of the Covenant Partners present.

<u>Section 5</u>. <u>Conduct of Meetings</u>. The Chair of the Board of Directors shall preside at special or annual meetings of the Corporation. The Clerk of Session shall act as the Secretary of the meetings of the Corporation and at Board of Directors meetings. The Board of Directors may designate substitutes.

ARTICLE V

Indemnification

The Corporation shall indemnify each Board member, all Corporation and Church officers, each employee and each volunteer of the Corporation and Church while each is serving in that capacity and after each no longer serves in that capacity to the fullest extent permitted under the laws of the State of South Carolina; provided, however, such person is acting reasonably and in good faith, within the scope of such person's authority and in the best interests of the Corporation. The Corporation may purchase insurance insuring its obligations hereunder or otherwise protecting the persons intended to be protected by this Article. The Corporation shall pay for or reimburse reasonable expenses incurred by any person indemnified above who is a party to any proceeding in advance of final disposition of the proceeding to the extent permitted under the laws of the State of South Carolina.

ARTICLE VI

Exclusive Organization

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII

Private Inurement

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to any member of the Corporation, Board member, any officer or Session member, or any other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes for which the Corporation was organized. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on any other purposes not permitted to be carried on (a) by an organization exempt from the federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code, or corresponding section of any future federal tax code.

ARTICLE VIII

Dissolution

Upon the dissolution of the Corporation, all assets shall be distributed to one or more tax-exempt organizations described in Sections 170(c)(2), 501(c)(3), 2055(a) and 2522 of the Internal Revenue Code, or any corresponding section of any future federal tax code.

ARTICLE IX

Rules and Amendments

These Bylaws shall not be altered or amended, unless such alteration or amendment has been approved by the Board of Directors and submitted in writing to an annual meeting of the Corporation, or a special meeting of the Corporation called for that purpose. At least fourteen (14) days prior notice (which must span two (2) Sundays) must be given of the intent to alter or amend the Bylaws at such annual or special meeting and the content of such proposed alteration or amendment must be provided in such notice. After determination that there is a quorum present of the Covenant Partners, a majority vote of the Covenant Partners present shall be necessary for such alteration or amendment.
